In order to participate in any of the All-State and Honors Bands, directors and students must follow these rules: a. The band director must be a member of NAfME/FMEA/FBA at the time of the audition, or at the time of the postmark deadline for those directors that are only nominating students for an Honor Band.

Handbook, page 18, III-F. JAZZ BAND MUSIC PERFORMANCE ASSESSMENT 4. Music selection is made at the discretion of the director. It is strongly recommended that the director play a swing chart at the Jazz Band Music Performance Assessment. Original compositions or arrangements are encouraged. Motion: J. Cayer/J. Langford

Rationale: The Jazz Committee feels that every group should perform at least one swing piece. Swing is the basis of all jazz music. Passed

Handbook, page 18, III-F. JAZZ BAND MUSIC PERFORMANCE ASSESSMENT 3. Instrumentation and Personnel, f. Duplication of personnel between first, second and third band is allowed under the following condition: The student should be attending and participating in the second or third Jazz band on a regular basis (just as any other second and third band members do). It is strongly recommended that students practicing and performing with other bands should do so on a second instrument.

Motion: J. Cayer/E. Rivero

Rationale: The revision to the handbook on this topic will add clarity as to criteria of personnel in the second or third band. It also follows along the same wording as the concert (section). Passed Unanimously PASSED by the BOARD

Rationale: Most of our student pianists started as Classical players - if they are preparing their Jazz Piano audition and want the opportunity to play for any All State Ensemble, this gives the option to have an "Auditioned" pianist in the ensemble. The best Jazz Pianist will still be selected for the Jazz Band - the next choice would be based on the jazz audition and classical etude. PASSED by the BOARD
