- 1. Intro from Cathi welcome
- 2. Marching Band changes
 - Timing and performance space issues in the Handbook
 - Some districts have given input and ideas
 - Special committee for marching band will be looking at the issues
- 3. Possible Solo and Ensemble changes
 - HS students to be allowed to perform grade 1 and 2 solo and ensemble for comments only.
 - Voted on in general meeting after passing the Dec. Board Meeting
 - If implemented, will be put in effect for the following school year (2018-2019)
 - There was a bit of discussion about whether they should be allowed to play for a rating as opposed to comments. Directors were reminded that if they felt strongly about that, they would have to DEFEAT this motion and either present one from the floor that passes OR send it from their district, meaning their students could be disqualified in this scenario if it doesn't pass.
- 4. January MPA meeting
 - Add extra meeting between May and July meeting so that the implementation can be done faster
- 5. Introduction of candidates for FBA president elect
 - Shawn Barat and Ian Schwint were introduced by Jason Duckett
 - Get to general meeting early to get ballots to vote
- 6. Board defeated the Life Membership qualification revision
 - Current rule: 25 years consecutive years of membership
 - People wanted to change it to 25 years of cumulative membership
 - New committee with Dayna Cole as chair will be meeting to discuss membership revision issues
 - Suggestion is to discuss it at the January meeting with your district. If you have a strong opinion, put it in your minutes as suggestions to committee to note for the special committee to see them at their meeting.
 - Have district chair contact Dayna if there are suggestions so they can be reviewed at their meeting.
- 7. By-laws changes
 - 7 changed will be presented in May and are pretty much cosmetic changes One is on next in line succession. One is a district line change
 - One is to add MS All State Jazz Band and Nine Star Honor Bands to sponsored activities. (We already sponsor them; just need to reflect that.)
- 8. Committee changes:

When a President has finished their term, they relieve all the committee chairs and the new president selects new chairs. Sometimes chairs stay on, but other times people are replaced. Often, they ask to step down their level of participation for a variety of reasons.

Junior High / Middle School Directors Meeting

Thursday, January 11, 201 6:30PM TCC West Hall Dayna Cole, Presiding

Topics of Discussion

- 1. The Honor Band Form are there any suggestions/ideas that you think would make the form better or more user friendly?
 - A. Some people were unhappy that all 12 scales were on the form. This form is the same for both the MS and HS Honor Bands. Also, there are many MS students who do know all 12 scales. The more information we have, the easier it is to select the ensemble.
 - B. PLEASE encourage your students to do solos at S&E. This is a time consuming venture that requires money, finding an accompanist, Smart Music, recordings, etc. I took this section of the form seriously in terms of grade literature/ratings and selection. Because all of our judges have to go through the training and certification process, this section provides a lot of insight as to a student's level of preparation and follow through based on common criteria. It will also benefit your band.
 - C. As a result of this form over the past nomination process, I feel the level of the MSHB has improved tremendously.
- 2. Middle School Honor Band Issues
 - A. Still many issues with paperwork. **DO THE CHECK LIST ON THE COVER PAGE AND INVOICE!** This check list addresses the inclusion of Student Participation Contracts, the fact that I cannot accept personal checks, signatures needed, and whether the director is a member of FBA. Many are not reading the directions on the form just merely filling it out. In the end, this hinders your school's opportunity of having a student in the Honor Band.
 - a. No contracts
 - b. Personal checks submitted
 - c. Missing signatures
 - B. The number of emails I send regarding the above issues is staggering. I can only send out those emails when the paperwork is submitted BEFORE the deadline and there is still time for you to get it in. **But this is done as a courtesy**. I am not obligated in any way to email directors when there is a problem with their paperwork.
 - C. There are several directors that go online and go through the process that do not actually send in their materials. You show up on my Ensemble Administration Site on MPA Online, but there is no follow through. You are not included on the current Schools Not Selected List for first consideration the following year.
 - D. Schools that did not have a student selected, that had incomplete paperwork, or the director was not a member of FBA you are also not included on the current list for first consideration next year.
 - E. Only schools that had everything in order and did not have a student selected are on the list for first consideration next year.
 - F. There are MANY DIRECTORS who submit only 1 student nominee (44 schools this year) and usually those student play the flute (32) or alto saxophone (22). Also, there were 45 schools that nominated 2 students.
- 3. The Process
 - A. I look for the instrument with the fewest number of nominees. This year it was Bass Clarinet. Once I select the 4 BCL's, I move on to the other instruments with a limited number of nominees.
 - B. If I have enough students to take 1st choices without doubling a school, I go ahead and do that. If I have too many, I take 8th graders first.
 - C. S&E participation is also a huge factor for me. There are many bands across the state that do not participate in Concert MPA, but waivers are available to allow your bands to participate in S&E. FBA S&E has approved adjudicators and the standard by which we adjudicate is held according to the Adjudicator Comment Sheet our rubric. I consider a superior to be pretty much the same across the board. This will also MAKE YOUR BAND BETTER!!!
 - D. I am bound to one student per school, so if your 4th choice BCL was one of my picks, then your 1,2, & 3 were left home. This is Wizard's Chess at its' finest!!!
