The committee was responsible for evaluating nearly 390 submission this year (24 were submitted by FBA members). Additionally, we expanded FBA member contribution to the committee by adding 16 members from across the state as "Contributing Members" who, in addition to the 10 "Sitting Members," participated in the first round of satellite screening and evaluating. This allowed for more eyes and ears on pieces during the first round of evaluations. Both Contributing Members and Sitting Members had equal votes during the first round of evaluation. Of the 19 pieces added this year, 7 were submitted by the FBA membership and not publishers. Below is the recommendation of the committee for additions to the FBA Concert Music List.

#### **DEC. 2019 MPA COMMITTEE REPORT**

Meeting Date: November 20, 2019

This special session of the MPA committee was held electronically to address the motions from District 6 and 13 in time for any changes to be in place for the 2020 concert MPAs.

#### SUGGESTIONS:

District 3: To The MPA and Sight Reading Committees: publish a standard protocol for tuning timpani during the sight reading process which includes where the appropriate time to tune is during the process.

Addressed in new Sight Reading Script

#### MOTIONS:

District 6 - Meeting 4 MOTION - Kuperman/Martin - Revamp the sight-reading classification levels. PASSED Rationale: Sight-reading classification is the same for levels MB, CC, C, and D; however, the minimum level of music literature for each classification is different. Additionally, the level of music depending on the size of the school can range widely for 2nd and 3rd bands, but all have classifications of C. Possible Solution: Classification of C read MC or MD sight-reading as it more aligns with the level of literature required.

#12-MOTION by M. Oser/Z. Murdock to send to MPA Committee PASSED by BOARD

Committee Recommendation: Vote this motion down as it does not have an actionable item.

District 13 - Meeting 4 Motion by Howell/Kalwa to change the Concert MPA sight reading level requirements for high school third and fourth bands to MB. Rationale: The difficulty level of the sight reading music should align with the music that is being performed on stage. As the highest level of music required (for A classification schools) is a grade 1 and 2, the C-CC sight reading music is often more difficult than the music performed on stage. Motion Passes by the membership

#23-MOTION by B. Mounger/Amy Beres to send to MPA Committee PASSED by BOARD Committee Recommendation: Vote this motion down as this is already the current practice.

#### Motion from the Committee: (Adams/Cole)

All third and fourth high school concert bands will sight read MC level sight reading at concert MPA. Rationale:

Currently all 3rd and 4th bands read CC-C-D-MB level sight reading; however, 3rd and 4th bands are only required to play 2 grade ones on stage. This means that they are currently sight reading at a higher grade level than they are required to perform on stage. By changing the sight reading requirement to MC the sight reading requirement is more congruous to the stage music requirement.

I have recently been named the chair of the Sightreading Committee, so I wanted to take a moment to inform and update the membership on the status on the work of this committee

Sight-reading Literature for the 2020 Concert MPAs has been selected and is currently in the process of being prepared to be sent to the district chairs. I would like to thank Larry Clark for his excellent work and guidance through this process. For those who don't know how it works, here is a brief summary:

Excelcia Publishing provides music that will be published in their 2020 catalog available to the FBA before it is available to the public.

- We use a rubric that can be found on the FBA website on the "Music Lists" page to guide us with regards to the classification level of each piece.
- The Sightreading committee reviews the selections and makes their final recommendation as to which march and overture will be assigned to each classification.
- Excelcia Publishing takes the selections and makes the books that will be used for the Sight-reading portion of the Concert Band MPA. Those books are then mailed to the 21 district chairs.

Other Sight-reading-related happenings:

- Lee Sellers has recently finished a script that all Sightreading adjudicators will be able to use to guide them through each band's sight-reading experience.
- A motion addressing the level of music that a second and third band will read at their Concert Band MPA is being considered by the Executive Board and the MPA Committee.

Dayna Cole, Chair, Solo & Ensemble Committee Report to the Executive Board December 3, 2019

My utmost thanks to Josh Bula for the many changes that have been made to the appearance and upkeep of our S&E Music List. A phone conversation with him and some ideas thrown around resulted in a much easier way to manage our list and, hopefully, a much easier, less cluttered way for directors to browse the list

Similar to the old drop-down format when you browsed the S&E List on MPA Online, the new format allows you to see much more information when you click on a title – publisher, number of times a piece has been performed, instrumentation of ensembles, etc. It will take a lot of time (man hours) to make all the changes, add all the information, etc., but it will get done in my lifetime!

One addition to the S&E List is a check box for solos that require extra time to be performed without cuts. Obvious cuts to the accompaniment introduction are acceptable, but cuts to the solo or accompaniment during the piece will not be allowed. Letters are going out to our State Adjudicators to ask for input as to which solos require that extra time.

The window for Special Permission is now closed. Requests will be sent out to adjudicators/band directors who have expressed a willingness to help with these requests. There have already been some instances where, instead of granting Special Permission, I have simply added the piece to the music list. Yes, it is now that easy.

A big thanks to Doug Moser and Seth Wexler for work they did on updating our Percussion List. Pieces have been changed as far as the grade of difficulty, pieces have been removed, and much more will be added in all percussion categories.

Additional thanks to Tammy Phillips, Rene Miska and Nora Lee Garcia for helping clean up the upper grades of the flute list.

There will be work that needs to be done to this list forever. I refer to it as a living organism. But I believe the changes that have been made will make managing the list easier and, in turn, make the list more informative and easier to navigate for our members.

- 1. Mike Tomaro has completed a chart for the 2020 All-State HS Jazz Band, which he is the conductor. \$1,000 Commission Fee paid
- 2. Haley Woodrow has completed a grade 3.5 piece for the 2020 All-State Middle School Band, conducted by Mike Garasi. The title of the piece is "HIM", which is about the hurricanes of 2017 that hit Florida. She will be present during FMEA for the "Meet the Conductors" Session on Thursday and in rehearsals throughout the convention. \$2,500 Commission Fee paid. Check her works out on her website at haleywoodrow.com
- 3. The 2020 Nine Star Honor Band will have guest composer Dr. Jeffrey Traster in residence for a new commission. Kelly Dorsey, conductor, has worked with Dr. Traster before and is excited to have a new piece from him for the occasion. It will be a grade 3 piece and the commission fee is \$1,500.
- 4. The committee is in the initial discussion of starting a composition contest. The Commission committee did a similar contest back in the 1980's and we want to explore bringing it back. The focus of this contest is geared towards Grade 2 level music. We hope to have the details locked in and bring to the board in May for approval.
- 5. Please take note of the commissions from the FBA that are being published!!!
- 6. The committee is seeking composer recommendations for the 2021 All-State Ensembles and Nine Star Honor Band. Please send any suggestions to the chair for the committee to review.
- 7. We are in discussions with Larry Clark about publishing Jack Stamp's piece dedicated to Linda Mann. Jack wanted any proceeds to go to her scholarship. Neil and Larry are working out those details.
- 8. It is not the philosophy of the Commissioning Committee that all works commissioned should be added to the FBA Concert Music List. Just because a work is commissioned by the FBA doesn't mean it meets the philosophy of the Music Committee. It is the goal of the Commissioning Committee to commission a wide variety of works from a wide variety of composers, who in turn may choose to compose a piece that is not a "MPA" worthy composition. #### **NEW BUSINESS**

#### PROPOSALS TO THE EXECUTIVE BOARD

(from District minutes - comes in the form of a motion):

Dist. 15

Motion (Rubio/Cole) - To specify for each instrument, the number of octaves per scale, based on practical range, to be played for All State Band Auditions.

Rationale:

- 1 We already do this for mallet auditions.
- 2 It would put everyone on an equal playing field.
- 3 It would remove any financial advantages for extended octaves, ie. a flute 3 octave B Scale, an oboe 2 octave Bb Scale, or any number of advantages for a trombone with an F attachment. These are all *financial* advantages that should not give students a *point* advantage. **Motion Carries.**

\*\*MOTION #11: J. Duckett/A. Beres: Refer motion to the All State Band Committee PASSED by BOARD

Dist. 18 (1<sup>st</sup> Meeting)

PROPOSAL: It is the desire of District 18 to split the district into District 18 (Lee and Hendry County) and District 22 (Collier County).

Rationale:

Scheduling:

- Due to transportation, Lee County schools have had to be dropped off four to six hours prior to a performance time and/or having to stay for the same reason. Lee County allows for busing between the hours of 10am and 1pm and again after 4:00.
- Due to the size of participants, Solo/Ensemble has become three brutally long days for the adjudicators.
- We already have many Assessments in a North or South location, however many Collier schools have three to four bands per school and still must go to the North Site.
- Lee and Collier Schools have a contrasting calendar year. Scheduling events without conflicts is a constant struggle.
- Difficulty finding adjudicators willing to forfeit three days of time.
- Difficulty in finding a host site willing to take on this multiple day responsibility

#### Transportation:

- Collier County must pay for own busing.
- Lee County (at times) will pay for busing only if it is in county. For three consecutive years, Lee County has received a grant to pay for busing to Collier County.
- Lee School can only schedule buses between the hours of 10am and 1pm and again after 4:00.
- Distance between furthest north and southernmost school is 54.3 miles while the midpoint is Estero High School at 25 miles...which is still in Lee County.

#### Difference of Academic school day:

- Between the 3 counties of District 18, there are vastly different approaches to Student scheduling.
  - o Lee County Middle School is on 5x5 block or 6x6 block
  - o Collier County Middle School is on a 7-period day.
- Directors in Lee County are at the disadvantage of only seeing their students every other day for 55 minutes. Time is an issue in the spring semester to prepare their students properly for MPA. Directors in CCPS would prefer an earlier MPA but this has not been a realistic expectation to place on our colleagues in neighboring counties. With HS MPA already being such a large event, it is not feasible to have middle school band perform at HS MPA

#### **Budget Considerations:**

- It is the belief that two separate Districts would eventually be more cost effective for all involved to hold smaller, more manageable MPA events.
- Less total judging time and closer sites means a lower assessment for everyone. It would also be easier to find judges, sites, and build a schedule that works for the schools involved.

#### Expansion and Community Growth:

- Collier County will be opening a new high school in the next few years.
- Lee County just opened a new high school 2 years ago and is in construction of an addition.

#### Why Not:

- 1. Cost to FBA two more hotels, two more account lines, two more travel, etc....at four meetings per year.
- 2. FBA would have to create another district to have an odd number of districts for voting.
- 3. Larger number of schools in other districts and they are not splitting

#### Solutions:

- 1. Have two different dates
- 2. Have two different sites. North and South

Skip Pardee: Motion to executive committee - move to form a second district... (encouragement for continued professional support even if districts split. There are more reasons for dividing the district than for staying. 2<sup>nd</sup> Ashley Crosby

Discussion: Ashley Crosby - assessments should stay the same and then may even get lower

Phil Barton: open up to more adjudicators

Skip Pardee: transportation issue with bus availability

Question: on favor of the motion to separate - motion carries - PASSED

NOTE: President Leibinger created a Task Force/Strategic Planning Committee to review all District allignments and the proposal from District 18.

\*\*MOTION #12: K. Griffis/T. Lewis: Refer the Dist. 18 proposal to the Strategic Planning Committee PASSED by BOARD

#### **SUGGESTIONS TO COMMITTEES** (from District minutes)

1. Jeremy George made a suggestion to the All-State committee about the Jazz Band audition: there is currently an option to select "double bass" or "bass" for the student's instrument, and he would like there to be only one instrument listed (confirm with All State Committee and make necessary changes)

#### Dist. 4

1. To Adjudication Committee: Lori Pirzer: Standardize the recording devices used to record comments at MPA's across the state or require judges to use their own device to upload directly to a MPA Online or Competition Suite.

Rationale: Every year at our MPA's, several judges have challenges several varieties of recording devices resulting in bands not getting entire or complete commentary. Standardizing the device would allow the judges to be trained the same way across the state ensuring that ability to use the device will not inhibit proper recording of comments. Uploading directly to MPA Online or Competition Suite would ensure that the recordings are uploaded immediately and easily distributed. Using their own device ensures that the judge is familiar with using the device. Mandating a specific recording device could result in financial savings by enabling the Association to potentially purchase devices on a contract or as a bulk order. (Much discussion by Board)

#### **Additional Suggestion:**

We should include in some of our "Best Practices" FBA literature that "Requiring students to audition for an All-State Ensemble as part of the school band curriculum is an unethical practice not supported by the FBA."

Rationale: When a student is required to audition for an ensemble or experience they do not wish to be a part of it presents significant challenges when that student is selected for that ensemble. For example, a middle school clarinet player who is exceptional at clarinet, but also plays tenor saxophone in the jazz band because their director asked them to. The student's director requires all their students to audition for the MS All-State Jazz band if they are a member of the school's jazz ensemble. The clarinet player who has only been playing tenor saxophone for a short time makes the jazz band and made the concert band, but is selected for the jazz band (even though they really wanted to participate in an all-state ensemble on their primary instrument, not on the instrument they were asked to play by their director to fill saxophone spots in the jazz band). Now the parents and students are stuck paying money for an experience they did not want nor ask for, but because they were required by their director to audition as part of a grade, now must follow through with.

Many clerical errors eliminated schools' eligibility for the Honor Band. As a courtesy, when incomplete paperwork is received before the deadline, an email is sent to the director, allowing them to correct errors before the deadline. Once the deadline is reached, this courtesy is considered.

Josh Bula added a pop up asking directors to nominate their best students first, reducing the overabundance of color instruments and lack of clarinets and trumpets.

HS All-State Honor Band Stats

Folders with music and information were sent to directors on November 22, 2019 via UPS.

372 total students nominated from the state before drops, down from 433.

129 schools nominated in 2019 (down from 139 nominations last year).

- 5 schools not accepted due to late or incomplete paperwork. These 5 are not included in the 129.
- 32 of 129 schools had students make the audition band.

Final count: 97 students representing 97 schools after All-State audition results. Down from 109.

0 of 97 students withdrawn this year due to late memberships.

1 of 97 students unable to attend All-State due to sudden financial strife caused by sudden loss of family member.

31 schools nominated only 1 student or one instrument on multiple nominations.

 We should consider requiring the director to nominate more than one student. Add to the checklist on the cover page.

23 second choices chosen.

Deadline for All-State paperwork was 9/13, All-State audition band results released on 11/1.

#### Summary:

As long as paperwork was in well before the deadline, any paperwork issues (missing signatures, incomplete submissions) were addressed and corrected by my contacting the director. The lower number of HS Honor Band nominations could be due to the very early deadline. It would be beneficial to consider extending the deadline (even just one week) for Honor Band nominations since we allow 3-4 weeks for All-State judging. Much higher number of nominations would be likely. Band director turnover might also be a factor. Make sure mentors/district chairs are encouraging first year directors to follow through with nominating honor band students. Would also like to require directors to nominate at least two students of different instruments in order to be considered. Some directors know that every school has to be represented and take advantage by nominating one student. Other directors that follow the rules and nominate multiple students end up having their second choice chosen in order to make room for single-nomination schools.
