Meeting called to order at 3:00 pm.

- Motion to approve Ian as new chair of finance committee (Cayer/Hendricks) - Approved Five motions and one suggestion sent to the Finance Committee from the 2021-2022 Board meetings were addressed.

#### PROPOSALS

• Dist. 12 - Meeting 4

• MPA and Finance Committee: David Fultz - Increase the auxiliary judge honorarium. Out of order as this is not a board actionable item; however, discussion of feasibility of increasing all adjudication honorariums did occur. This discussion will be presented under points of information below. **#1-RULED OUT of ORDER by PRESIDENT HENDRICKS** 

- District 10, meeting 2
  - Proposal: Carolyn Deck, 2nd by Benjamin Hart: New award entitled "Esprit de Corps" award. This award would be nomination based similar to the Tom Bishop or Oliver Hobbs award. The purpose is to recognize a band director who embodies the qualities we desire amongst our membership in the FBA.

-Recommendation to defeat this motion due to unknown financial future. Current cost increase of medals and plaques has been more than anticipated and still rising.

#### **#2-MOTION DEFEATED by BOARD**

- District 14, meeting 2
  - Michael Fraley-Life Member FBA-Don Estridge High Tech Middle School Boca Raton, FL Second-Andrew Lopez Motion Passes Motion: The FBA Finance Committee should find an equitable way to distribute interest earned on reserve fund account money that they hold for the districts. 23 Rationale: Since at least 2007, FBA has held this money. Many districts have built up a significant amount of money and should be properly credited with their fair share of any interest earned on the money held. Motion Passes

*-Recommendation to defeat this motion due to the financial insignificance.* **#3-MOTION DEFEATED by BOARD** 

- Dist. 19-meeting 1
  - Flenner/Crouch: Motion to add a five-year superior award for high school and senior high band directors whose bands earn Superior ratings at the FBA District Concert Music Performance Assessment for five consecutive years. Motion Passed. Rationale: High school directors that achieve this honor should be Summer 2022 Bulletin

recognized, just like the middle school directors are recognized. Not every band belongs at State or can consistently achieve a Superior at State, but FBA should be willing to honor those directors who work for consistency and excellence at their high schools. #### SUGGESTION

- Dist. 16 Meeting 4
  - I propose we change the structure of Adjudicator payment to be a raised flat fee for each MPA event by hour instead of including mileage, tolls, meals, etc. Rationale: This will allow better budgeting for districts and have adjudicators not accept jobs based on how much mileage they may earn. This will also allow judges from other areas to not be cost prohibitive as well as making it easier/cost efficient to hire judges from further as well. Creator - Jen Jimenez; 2nd - Anna Goebel)

-While the committee sees merits to this suggestion, the committee is not ready to act on it due to the fluctuation of expenses.

#### DISCUSSION

Significant discussion concerning the summer conference and the creation of a summer conference specific budget by the summer conference facilitator. This budget will be presented at a finance committee virtual meeting in December.

Medacraft - Possibly time to start looking into creating a task-force to look at the feasibility of bidding out our medals. Medalcraft costs continue to rise and there could be better options. Possible to go to the Awards committee. We will continue to discuss this. Current contract with Medalcraft expires June 2024. Now would be time to start looking at other vendors.

#### MOTION TO THE BOARD

The following membership fees will be in effect starting in the 2023-2024 school year.

### 6. USE OF MIDDLE SCHOOL STUDENTS

A High School with 800 students or less in grades 9-12 or a Senior High with 600 students or less in grades 10-12 may use 7th, 8th and 9th grade students from a separate Junior High or Middle School in the same town under the following provisions:

1) Application for permission must be made in writing to the FBA Executive Director by September 30 of the year for which permission is requested. The application should give justification for the request and it must be on school letterhead and signed by the band director(s) and principal(s) at both the schools affected.

III C. 3.

d. is missing from this section. Change would pertain to current paragraph k. which should now be j.

Only directors or principals whose names appear on a school's Entry Form may register, transact business, or receive adjudicator comment sheets from that school, unless another person presents a letter of authorization (to the MPA Officer), on school letterhead signed by the band director and principal.

Proposed Handbook Change - page 12. (Subsection 3 is in twice with no 4.)

#### 7. REQUESTS FOR SPECIAL PERMISSION

a. FOR WAIVER OF MARCHING AND/OR CONCERT REQUIREMENT - Submit a letter to the President and Executive Director on school letterhead signed by both the director and the principal giving detailed justification for the request. Deadline: Postmarked thirty days prior to the event affected.
b. TO PERFORM OUT OF ASSIGNED DISTRICT OR STATE REGION - Submit a letter to the Executive Director (and District Chairperson for District) on school letterhead signed by both the director and the principal giving detailed justification for the request. Deadline: Postmarked fifteen days prior to the event affected. (See III.C.1.d. for criteria)

e. TO **WAIVE RULES REGARDING DNA PENALTIES** - Submit a letter to the Executive Director on school letterhead signed by both the director and the principal giving detailed justification for the request. Deadline: Postmarked thirty days prior to the event affected.

f. TO **REQUEST PERMISSION FOR "C" or "CC" SCHOOL TO USE STUDENTS FROM A SEPARATE JR. HIGH OR MIDDLE SCHOOL** - Submit a letter to the Executive Director on school letterhead signed by both the director and the principal giving detailed justification for the request. Deadline: September 30. (See EXCEPTION under III.A.3.)

g. ANY OTHER CIRCUMSTANCES NOT COVERED IN THIS SECTION may be dealt with by submitting a letter to the President or Executive Director on school letterhead signed by both the band director and principal giving detailed information and justification for the request.

3.f.. Only directors or principals whose names and signatures appear on a school's entry form may register students or receive adjudicator comment sheets for entrants from that school unless another person presents to the MPA Officer a letter of authorization on school letterhead signed by the director and principal. **MOTION: PASSED by the BOARD**

1. Proposal to strike from the handbook: (III-A.9.c. page 6)

This request (of a classification) will then be presented at the second FBA District Meeting for a vote by secret ballot of the membership of that District. If passed by the District, the request will then be reviewed and action taken by the Board at its November/December Board Meeting.

Now the handbook will simply read:

c. Requests for a band to perform in a lower classification must be in writing stating the circumstances justifying the request and must be signed by the band director and the principal of the school making the request. The request for classification letter MUST be attached to the classification form, which is due October 1st. *The new process is to simply file. Once filed, this will be the school's new classification.*

Auxiliary judges have been requesting a "Superior with Distinction" rating at the state level of solo and ensemble for a number of years. After lengthy discussion, we decided the criteria for such a rating would require straight A's from all three judges. As the 2022 state solo and ensemble event progressed, we discovered this honor would be earned by a select few. Students would not only have to excel in the areas of technical excellence, and general effect, but have to create a solo that is both innovative and thoroughly musical. It is our hope to establish this new rating in an effort to inspire the best and the brightest of our students to push beyond their current abilities.
