The committee is working on updating the FBA Adjudication Manual based on questions/concerns raised in recent months. Changes/Updates include:

- Adjudicators who have not worked in the last 5 years and are not currently teaching will become inactive, and will have to re-enter the approval process.
- New adjudicators (except auxiliary) should have a music degree or comparable certification.
 - Candidates with non-music degrees and/or professional experience may apply, but will have a supplemental form to supply additional information/references. The committee will meet twice per year to vote on these candidates.
- Candidates are required to have six years of experience to be eligible. This experience must be after the college degree (bachelor's degree).
- Adjudicators should only be hired for the categories for which they are approved. Hiring an adjudicator for a non-approved category will require committee and/or executive director approval. (Similar to hiring someone not on our list)
 - It is critical for the integrity of our assessments that we make every effort to hire approved adjudicators only.
- Adjudicators will be provided single-occupancy accommodations for all events.

Other notes:

- Adjudicators are independent contractors, and do not have a property right to employment with FBA. FBA reserves the right to remove an adjudicator from the approved list or active status. This statement (or similar) will be added to adjudicator applications in the future.
- The committee will be producing a "best practices" for hiring adjudicators soon. This is one of our most important jobs.
- Moving forward, we will be identifying "high needs" categories and will be actively recruiting to improve deficiencies on our adjudicator list.

FBA MPA SPECIAL COMMITTEE REPORT December 2-3, 2022 State Board Meeting

The purpose of this special meeting was to address the large number of suggestions and proposals to the MPA Committee. Many of the suggestions and proposals that are associated with the ongoing concerns regarding classification were discussed in concept only and will be addressed at our official meeting in January. Several other suggestions and proposals were discussed and suggestions to the board were made.

Suggestions to MPA Committee

Dist. 3 - Meeting 4

March and Overture sight-reading time limits are wonky; can we adjust the timeframe for preparing to play the pieces? Please review and see if we can make a change.

Response:

The time limits for both the march and the overture sightreading have been discussed and the committee recommends no change. The intent of the time limits is to review any concepts and techniques that need to be addressed before the band's performance, rather than to rehearse the entire selection from beginning to end. It is the director's responsibility to monitor and manage their time in the sightreading room to cover any of the concepts they feel most important to a successful performance. It is standard practice for the adjudicator to provide a one minute warning before the time is expired.

The MPA Committee recommends the Clinics Committee consider including a sightreading clinic at the FMEA convention that addresses these concerns.

Dist. 8 - Meeting 4 (suggestion #1)

MPA / Sight-Reading Committee: Sight Reading procedures for Timpani.

The FBA Handbook states, "Once sight-reading music has been distributed, there can be no sound generated by any instrument during the preparation time. EXCEPTION: The tympani may be tuned (Pg. 18, Section 3-C-3)."

Suggestion: My suggestion is that the timpani notes be written on the board and/or told to the timpani player BEFORE the instruction period begins. The ideal time to tune the timpani would be when the judge is going through the rules, helpers are handing out music, and students are checking that they have the correct parts. I do not suggest giving the timpani player any extra time to tune, but rather to tune while other "housekeeping procedures" are happening. I fully understand and agree that we cannot allow the timpani player to tune after the instruction periods because that could potentially provide the wind players and other percussionists more time to look at their music. Additionally, timpani players could "stall" by tuning slowly, which is precisely why the tuning needs to happen BEFORE the instruction periods and BEFORE any other students look at the music. If the timpanist is not ready to tune before the instruction period for any reason, then the student must follow FBA guidelines and tune during the instruction periods.

Response:

This process is already in practice and may need to be clarified by a district officer to the sightreading adjudicator during the judge's meeting preceding the first event at the district Concert Band Music Performance Assessment.

Currently, the handbook reads:

III-3 3 c. - Once sight-reading music has been distributed, there can be no sound generated by any instrument during the preparation time. EXCEPTION: The tympani may be tuned.

The sightreading script reads (prior to or during the distribution of the sightreading books but before the students are instructed to open the books.):

If your band is utilizing timpani - In order to facilitate the tuning of the timpani, your conductor may assist as needed during this time. They have the scores, so remember to not open your book. Percussionist may tune the timpani while the books are being distributed. If the student needs additional time to tune, he/she may do so during the instructional period.

Dist. 8 - Meeting 4 (suggestion #2)

MPA Committee: Concert/Jazz Rating Permutation corrections/clarifications in handbook Section C – General Information Regarding MPAs, No.8 - MPA Ratings and Charts (pg. 13) d. Three Concert Jazz Band Ratings in Every Combination (pg. 13)

Note: If one of the three ratings is more than two divisions below or above the other two, that rating is disallowed in the final averaging. Ratings falling into this category appear in the chart above (pg. 14). The chart May Bulletin 2022 16 above shows the final rating as if the policy language, three of the ratings combinations would be raised (SGG = E, EFF = G, GPP=F) and three would be lowered

(SSG = E, EEF = G, GGP +F). If the chart reflects the memberships wishes, then the policy language in this note should be changed to "two or more."

Note: Converting ratings to letter grades (S=A, E=B, etc) one can determine the letter grade average for any combination of grades assigned. (pg. 14) This would handcuff an adjudicator somewhat. For solo/ensemble, ratings of ACC, suggest a strong player who was not prepared to perform this particular selection, would have a result in a Good, rather than an Excellent. For the three selections of a jazz or concert program, grades in one category (Technical preparation, for example) of a ACC, suggesting a band that did a solid job on their opening number but struggled on their other two, would have to result in a C, rather than a B.

Would like the MPA Committee to review this and adjust in one of the following ways.

- 1. Remove from the handbook, Article III, Section C, No. 8, Item d. And add notes "this would result in straight averaging of three judges's rating and three letter grades on a sheet, and a new chart of combination would be published"
- 2. Correct the III.C.8.d chart so it matches the policy language of the following notes: "Three would be raised, three lowered."
- 3. Correct the note (top of pg. 14) so that the policy reads "two of more", matching the III.C.b.d. chart.
- 4. Remove from the handbook the second note, top of pg. 14, requiring that the average of three letter grades on a sheet follow the formula of three judges' ratings.

Dist. 12 - Meeting 4

MPA and Finance Committee: David Fultz - Increase the auxiliary judge honorarium.

Response: The finance committee has taken action on this suggestion and raised the honorarium for all adjudicators. Discussion took place regarding the additional responsibilities of an auxiliary judge and will addressed in a separate suggestion.

Dist. 18 - Meeting 4

MPA Committee, Sight Reading Committee, et al: Modification of the current "Classification System".

Directors would no longer submit a classification form. In the case of Concert Music Performance assessment, Directors will still be required to perform a march and select two (2) musical selections from the Florida Bandmasters Association approved concert music list for each ensemble entered into Concert MPA.

Directors would not be able to perform two selections that are more than two (2) grade levels apart, i.e. for the two pieces other than the march, if a Director selects a grade VI (6), their second piece would have to be: a grade VI (6), grade V (5), or grade IV (4).

As for sight reading this modified classification system would present a more pedagogically sound approach where the ensemble would sight-read around/approximately two "grade levels" lower than the ensemble's most difficult piece performed on stage.

For example: a director selects a march, a Grade VI (6) piece and Grade IV (4) piece to perform at Concert Music Performance Assessment, that ensemble would now sight read out of the

new/renamed Grade A (Currently A/AA... approximately grade 3.5 book/packet)... because two (2) levels below Grade 6 would be Grade 4.

Ensembles would still need to play a minimum of two grade III's to qualify for state concert MPA. Only Grade III or above music would be allowed to be performed at state concert MPA. Only High School and combined schools would be able to qualify for state concert MPA.

Dist. 21 - Meeting 4 (suggestion #1)

Sight-reading and/or MPA Committee: Sellers

A discussion and action need to take place concerning electronic devices in the sight-reading room at concert music performance assessments. During the three sight-reading MPAs I judged this past season, there were seven different occasions when I had to stop the sightreading process, by pausing time during the preview period to handle various cell phone issues (parent not following my request to power down, device ringing during a preview period, etc.). Discussions in committee should include: The use of ABUNDANT signage outside and inside the sightreading room regarding electronic devices, stringent disqualification policy regarding the use of electronic devices during the sight-reading process, with this policy stated during the sight-reading judges' script. This policy should clearly state that an infraction will cause the band to be disqualified from both the concert and sight-reading categories of the CMPA, with adjudicators' comment sheets destroyed.

Rationale: We all sign documents stating that we could lose our teaching certificate, and even be held criminally liable for breaching testing protocols during standardized testing in our individual schools. We can certainly add this less-stringent protocol to our CMPA. This policy will strengthen the validity of our CMPA.

Response:

The committee suggests the design and implementation of signage (similar to our state's standardized tests) to be posted in and around the sightreading room. The security of our testing materials must be handled in a professional yet serious manner. While most observers do not have ill intent while recording their child in the sightreading room, it is critical that we maintain a secure testing environment.

Dist. 21 - Meeting 4 (suggestion #2)

Sight-reading and/or MPA Committee: Sellers

A discussion and action need to take place concerning the MD classification selections used for sight-reading during concert music performance assessments. Discussions should include: The possibility of commissioning selections for this classification in order to provide appropriate materials, how those materials could be integrated into the current format and remain secure.

Rationale: We are currently relying on music that is newly composed to be sold in the open market. If music appropriate for MD classification sight-reading were to be composed, no one would buy it. That would be a waste of resources for a publishing company. This immediate past season's sight-reading materials for MD consisted of two selections that were released to the open market one year ago. Both the march and overture were available for purchase BEFORE our CMPAs this school year. This is because there were no selections available appropriate for MD offered, so an executive decision was made to look at last year's offerings and use selections from that list. This unfortunate emergency decision left our

sight-reading process for MD bands essentially invalid this year, which is one of several reasons we went to the current system to begin with. Several marches and overtures could possibly be cycled/re-used if we had a way to keep them secure.

Response:

The MPA and Finance Committees approved funds to commission both an MD march and overture. This commission will be implemented in the 2022-23 school year. Since the sightreading selections are printed in the book each year, it is suggested that this level march and overture be written new each year to prevent potential abuse of the process.

Dist. 7 - Meeting 4

FBA Proposed Classification/Sight-reading Changes

This letter is in response to the Proposed Handbook Changes coming before the board in May 2022. I, along with the majority of FBA, agree with moving our classification system away from school size. This conversation/discussion has been going on for many years and it is refreshing to see some action on this issue. However, with that said, we as an organization must take the time to get this monumental change correct.

May Bulletin 2022 21

The number one question to ask ourselves is "What is the rationale for sight-reading?" In my opinion, sight-reading is the ONLY aspect of concert MPA that truly reflects the students' retention of

conceptual learning within our band rooms. The actual music being performed on

stage is taught to the students in various ways, thus sometimes creating a false sense of learned concepts. Some may argue the rating earned would verify conceptual learning, but does it really. The sight-reading process shows the conceptual mastery level of student performers.

Questions to consider:

1. Why have a "new" classification system with MD, MC, or MB? If everyone can select his or her grade of music, then just have a tiered lettering system (see below).

2. Why does middle school cap out at MB?

If middle school bands want to play much harder music, then they should be able to read at the level of music they select. The system should be the same for any grade level; the music you select for stage performance, that band should read that "grade" level for sight-reading. This comes back to just have a tiered lettering system (see below).

- 3. Why separate MS and HS? Just have a tiered lettering system that falls in the grade level for Sightreading music (see below).
- 4. Will the sight-reading rubric be aligned with this new grade level suggested?
- 5. Will the sight-reading music actually follow the rubric for the appropriate grade level?
- 6. If adopting a tiered system like below, then Proposal #2 to make Classification E a permanent classification in our handbook, would be eliminated. The permutations of music grade would apply to determine Grade of Stage Music, which relates to classification selected.

Motion: to add sight reading proposal below. Cole/Uhler

Classification Music Requirements Sight Reading Requirements C1 5., .5/.5,1 8-16 measure rhythm/chorale C2 1,1/1,2 16-32 measure rhythm/chorale C3 2,2/2,3 .5-1 C4 3,3/3,4 1-1.5 C5 4,4, 4/5 2-2.5 C6 5,5/5,6/6,6 3-3.5

C1 is for brand new middle schools or middle school 3rd bands

C2 is for middle school 2nd bands

C3 is middle school top/only bands

There should be a 2/2 Middle School Top/Only Band requirement.

Maintain a Level 3/3 High School requirement to be eligible for State Concert MPA. For State, HS Bands must perform AT or ABOVE the classification they chose at District.

These requirements would help to maintain the integrity of our standards while still allowing Directors the autonomy of determining their own classification. Band Directors would CHOOSE their own classification for each ensemble for the 1st Year. In subsequent years, the Director would have the freedom to remain at their chosen classification, move UP to ANY classification, or to move DOWN by ONE classification. If the Band Director deems it necessary to move down by more than ONE classification level, they would need to write a letter to the Executive Director, signed by the Band Director and the Principal, explaining the extenuating circumstance. School split, Director change – these would be acceptable reasons for moving down more than ONE Classification Level. In essence, this is what we already do through our Request for Classification accommodation. The only thing this system does differently is that it ties SR to the level of repertoire a Band Director selects for their MPA performance.

There would need to be considerations for 2nd, 3rd ... ensemble requirements, Director changes at a school, schools that have not participated in MPA for many years, etc. This is simply meant to provide a framework for a system that still has minimum requirements and still requires music to be played from our MPA List, but now affords Director choice instead of outdated imposed requirements.

Rationale: Some people feel as though allowing Directors to choose their Classification or creating a Grade .5 List would lower our integrity and standards. I would argue that integrity has more to do with the quality of our MPA Performance List and that the standard is our Adjudicator Comment Sheet. A good adjudicator should be able to evaluate the performance of a Bb Concert Scale or Music from Prague if the rubric is used correctly. But to say that perhaps a Band still needs to work on fundamentals if all they can play is a .5 is the whole point - a .5 is fundamental. Middle Schools should be able to build their programs by meeting the students where they are and going through an evaluation process that gives constructive feedback that leads to improvement.

Currently, a HS Top Band is required to perform a Grade 4 and a Grade 5 (9) at our highest classification. That same HS Second Band is required two Grade 3's (6), and their Third Band a Grade 1 and a Grade 2 (3). This progression allows for proper skill development each of the Bands would sight-reading at different levels.

This same type of skill development is NOT afforded to our Middle School Programs. At our highest classification (MB) a MS Top Band is required to perform two Grade 2's (4). That same MS Second Band is required to perform two Grade 1's (2), and so is the Third Band.... AND the Second and Third Bands sight-read the SAME MUSIC.

When we say that perhaps that second or third band should not perform at MPA and should instead focus more on fundamentals - well that is the purpose of MS Band! If we do our jobs correctly and teach solid fundamentals, we are preparing our students to go into their HS Band programs with the skills they need to succeed. This is what every subject should do. Do students in Primary Grades NOT do testing because what they are learning is too basic? No, they get tested to make sure they are acquiring the skills they need to move on to the next level. Can we not grade 2+2 the same way we would a calculus problem? Regardless of the level of difficulty of the music, we should be able to evaluate the fundamentals of a performance. Passed

Motion by B. Grieb/P. Arnold to Send to the MPA Committee, Sight-reading Committee, and Classification Task Force. MOTION #24: PASSED by the BOARD

Response:

No action taken at this time. This will be discussed at our January meeting.

Dist. 15 - meeting 4 (Motion #2)

Motion J. Sawyer/E. Rubio: Reduce the amount of required sight-reading pieces from an overture and a march to one piece written for the purpose of evaluation to add time to add clinics at the conclusion of sight-reading. This piece would meet the minimum requirements as outlined for sight-reading level per FBA.

Passed.

Motion to Send to the MPA Committee - T. Lewis/C. LaFlam MOTION #25: PASSED by the BOARD

Response:

The MPA Committee recommends defeating this motion. The march is an integral part of the Florida Bandmasters Association history and should be preserved in the sightreading process. The overture allows for diversity in the sightreading process, while still maintaining our heritage.

Dist. 17 - meeting 4

Motion: Ted Shistle: I propose that classification be based on the highest grade level of music performed (either selection) at Concert MPA and that there be no distinction made between middle school and high school classification. The standard of adjudication does not (should not) change whether a middle school band or high school band is performing. The difficulty of literature defines the developmental appropriateness of what is being assessed. There should not be a cap on sightreading for middle school just because they are middle school.

If a director is feels grade 4 or 5 music is developmentally appropriate for middle school, they should be held to the same sightreading standards of high school bands programming music of the same difficulty. Additionally, I suggest that and average of the two graded selections opens up the door for some potential challenges when it comes to programming. Perhaps the highest

grade difficulty should dictate the sightreading category. Permutations of classification based on difficulty of most challenging graded stage performance could look something like:

This may not be THE answer, but I believe that what is being proposed by the board has many pedagogical and philosophical flaws and should be reconsidered.

Solo & Ensemble Committee Report to the FBA Executive Board

The S&E Committee received approximately 185 submissions for Special Permission/Add to the List. At this time, selections are either added to the list or denied. The only consideration for Special Permission is a selection composed by a student, or if there is an instrumentation change.

The Committee Chair solicited the help from the following:

Folders containing instrument specific solos and ensembles were sent to the committee for their recommendation on whether the piece should be added, movements, grade, etc.

Directors will be notified if their submission is denied. All other pieces will be added to the S&E Music List. All ADDITIONS and NOTIFICATIONS will be complete by 12/7/2022.

Items to address:

<u>Steel Drums</u> - It is the opinion of the Chair that FBA should NOT add a Steel Drum category to our Solo and Ensemble events. FMEA has a Steel Drum Festival for serious steel bands. Even though it would allow for more student participation, I do not feel a Steel Drum category falls under the auspices of FBA.

However - if the majority of the Board wants to add this, here are some thoughts from Doug Moser, the Percussion expert on the S&E Committee.

- 1. Are there enough Steel Band Ensembles to justify this?
- 2. There is no Jazz Band music list, and I would put Steel Band in the same category.
- 3. Continuing to use the Special Permissions process to allow these groups to perform at S&E hasn't been a problem and might be the easiest/best way to continue, in my opinion.
- 4. For Steel Pan Solos, there is not a ton of published music out there. We could allow students to play Grade 1-3 mallet, flute, or oboe solos on steel pan, along with the few titles that are out there.

Choirs playing from the Quartet, Quintet, and Sextet lists, with parts doubled -

III-G.2.g. BRASS AND WOODWIND CHOIRS may play music from the quartet, quintet and sextet music lists, but THERE MUST BE AT LEAST TWO PLAYERS PER PART when these are selected. PERCUSSION CHOIRS must have at least seven players.

The motion made from Dist. 7 at the May 2021 Board Meeting, to allow choirs to play from the Quartet, Quintet, and Sextet lists with <u>at least one part doubled</u> is not something I am in favor of. A quartet with at least one part doubled would be a quintet - and a quintet would be a sextet. I have made several exceptions to the above over the past few years. For example, I have allowed a Saxophone Ensemble to play from the quartet list but not double the Bari Sax part, thus making it a Septet, which is in accordance with the minimum SEVEN players in a Percussion Choir. I would rather make an exception to the current requirement than to change it.

The FBA Awards Committee met on Friday, November 11 to review applications for the Tom Bishop Award and Oliver Hobbs Award:

- 9 applications for the Tom Bishop Award were received.
- 11 applications for the Oliver Hobbs Award were received.

The committee determined awardees and shared recipient names with Neil Jenkins.

Discussion:

- 2 applications for the Tom Bishop Award were incomplete. Clarification on the application process will be provided next year including:
 - Application will list the application process (this was listed on a separate document this year).
 - Application will also include additional information that would have been helpful during the discussion process including district number and years at current school.
- It would be helpful if nominees provided records (in the form of a list, that could be cross-checked against district meeting minutes) of attendance.
 - In reviewing attendance records, we discovered some districts did not provide full meeting attendance
 lists. If this is part of the award requirements, this should be something that is documented more clearly
 by districts.
- The FBA Bylaws list the requirements for the Tom Bishop Award more specifically than the FBA website.
 - The Bylaws are more up-to-date than the website description of the award requirements.
 - This was noted to Neil Jenkins and is in the process of being updated with Josh.
- Recommendations from Neil Jenkins included adding committee members to include the Past President and President, as well as retired members and members from the areas not covered by the current committee (Northeast Florida and Southwest Florida).
 - Additional members would ensure that there is adequate coverage of committee members in the event that committee members are unable to vote because they are an applicant for an award.
- Oliver Hobbs Award nominations are very difficult to determine given that there is a maximum of four awardees per year.

- Districts should make their best efforts to nominate the most deserving individuals with consideration given to that some nominees must go through the process multiple times for the chance to be considered (due to the limitation of four awardees). Age isn't a consideration of the award, but it is difficult when limited to four awardees to consider the many deserving candidates while also comparing them to directors who have been nominated multiple times.
 - Why is this limited to four? Are there other requirements that should be considered to help clarify who should be considered for this award? This is something worth discussing and considering.

To Do:

The Medalcraft contract expires at the end of 2023 and we will be checking prices with other companies to determine if this is our best option regarding S&E medals, plaques, etc.

I would like to suggest that we consider changing the order of the percussion all state auditions for all levels. As currently constructed, the audition requires students to move an inordinate number of times. Having recorded these auditions in my district several times, the mental toll and uncertainty these logistical maneuvers require while also requiring the directors to maintain a script and not offer feedback is unnecessary. These movements and changes of instrument could be significantly reduced in number by simply placing the mallet etude as the last required etude. This would allow students to play their mallet etude, scales and mallet sight-reading all at the same station. In light of this, my proposed order for the audition would be: Timpani etude, Snare etude, Mallet etude, Scales, Mallet Sight-reading, Snare sight-reading. Thank you for your consideration and all you do for our students.

D-23: Meeting 2

All State Committee: Motion for FBA to reconsider the scoring rubrics for All-State Jazz Auditions. As it stands, there are no points given for improvisation. There are however extra points given for the Lead Trumpet Etude. For years, Florida has had some of the best High School Jazz bands in the nation and I believe the students are being evaluated unfairly. Most serious Jazz students allocate a significant amount of their practice time toward improvisation, transcription and harmonic analysis to aid them in improvisation. I believe the proposed changes to the scoring rubric would make the All-State Jazz selection process more equitable for serious Jazz students.

I propose that the two improv selections be given a total of 30 points each and then each student's

points be divided by the point total of the categories they elected to compete in. Proposed points would be: Improv:

Harmonic Language /10 Rhythmic Feel & Swing /10 Tone & Style /10

Examples:

Student #1 - Saxophonist with no improv would be scored in 4 categories: Etude 1 (50pts), Etude 2 (50pts), Sight Reading (40pts), Musicianship (30pts) = Total 170 pts.

Student #2 - Trombonist with improv would be scored in 6 categories: Etude 1 (50pts), Etude 2 (50pts), Improv 1 (30pts), Improv 2 (30pts), Sight Reading (40pts), Musicianship (30pts) = Total 230 pts.

Student #3 - Lead Trumpet with improv would be scored in 7 categories: Etude 1 (50pts), Etude 2 (50pts), Lead Trumpet Etude (10pts), Improv 1 (30pts), Improv 2 (30pts), Sight Reading (40pts), Musicianship (30pts) = Total 240 pts.

The Judges would then convert the point totals into a percentage (150pts/170pts = 88.2%, 225pts/240pts = 93.8%). This would appropriately give an advantage to students who are able to improvise at a high level. I believe that any student who has studied Jazz music enough to be able to solo in a harmonically advanced way with proper rhythmic feel and historically accurate tone & inflections will also be able to perform their section parts at a higher level.

- Population of school does not and should not determine the size of a band, or the quality of students in the band, or the scheduling/administrative hurdles that may or may not exist.
- No math and reading standards have stood unchanged for over 30 years.
- No one knows better whats going on in a school better than the teacher that is there.

Discussion: Against-

- o Already able to opt out, fairly easily
- O The classification lets you know and communicate to admins where band should be and have a conversation with about why band is not able to be there. [Though this may unintentionally have admin blame teacher rather than factors the admin controls]
- o Removing the classification may unintentionally cause some directors to over program, this has been seen in other states [this means that sandbagging is less of a problem in those other states than some believe it would be].

BRASS AND WOODWIND CHOIRS may play music from the Quartet, Quintet and Sextet Music Lists. Each part must be represented by at least one player, and at least one part must have two or more players. PERCUSSION CHOIRS must have at least seven (7) players.

MOTION to send to the S&E Committee by T. Lewis/M. Antmann

*MOTION #8: PASSED by the BOARD (to S&E Committee)

Section III, G 4, n. SEP DEFINITIONS FOR CHOIRS BRASS & WOODWIND CHOIRS may now play music from the Quartet, Quintet and Sextet Music Lists, but THERE MUST BE AT LEAST TWO (2) PLAYERS PER PART when these are selected.

BRASS & WOODWIND CHOIRS are ensembles with at least one part doubled in performance. The literature performed must have four or more distinct parts. The number of players on a part will be assigned at the director's discretion with the goals of achieving balance in performance and engaging more students in Ensemble experiences beyond the full band. PERCUSSION CHOIRS must have at least seven (7) players.

Literature for Choirs may be drawn from the Choirs List and the Quartet, Quintet, and Sextet Lists that feature like-instrument and traditional chamber music instrumentations. Literature listed under the category CHOIRS will feature music with non-traditional instrumentation or more than six parts. Only choirs of 7 or more participants may be conducted.

PERCUSSION CHOIRS must have at least seven (7) players.

MOTION to send to the S&E Committee by A. Griffis/C. LaFlam

*MOTION #9: PASSED by the BOARD (to S&E Committee)

Rationale: Changing the wording as suggested above will allow more students to experience Ensemble performance beyond their full-band experience, and it allows directors to better focus the development of their bands. For example, a school with 7 horns in the program would be allowed to play together in a horn choir by performing a Quartet, Quintet or Sextet from the List with an uneven number of players on parts. Furthermore, this flexibility allows directors to engage any number of horn players and balance part assignments relative to player strengths. Considering the very limited music literature with 7 distinct horn parts, with the current wording, these 7 horns would not be permitted to play in a choir together. In fact, the current wording in these two sections of the Handbook PROHIBITS choirs with unbalanced part assignments from performing at Solo and Ensemble MPAs. Simply stating "they could separate and play a quartet and trio" may not be the best option for that program, and does not give those students the opportunity to play in a choir setting. The FBA encourages Solo & Ensemble experiences to broaden student musicianship, which then transfers to all aspects of our band programs. In Concert Band settings, best practice allows for a varied number of students assigned to parts. Allowing this same flexibility in S & E Choir performance replicates the reality of our programs. Very few Concert Bands have equal doubling on all three clarinet parts. Usually there are fewer 1st clarinets compared to 3rd clarinets; it is left up to the director to decide the doubling of parts in order to cover all parts and achieve ensemble balance. Lifting the limitations in these two sections of the Handbook allows more flexibility with forming Choirs, increases student participation in S&E, and better serves the development of band programs across the State.

This is a proactive initiative to support music directors when selecting literature for our music programs. The Florida School Music Association (FSMA) is responsible for the oversight of all

interscholastic music events in Florida. FSMA has empowered the following Florida Music Education Association (FMEA) component organizations to facilitate and supervise music performance assessments annually for ensembles and solos/small ensembles: Florida Bandmasters Association, Florida Orchestra Association, and Florida Vocal Association.

Each component curates a Required Music List(s) for at least a portion of Music Performance Assessment programing. Inclusion of a specific composition is reviewed by a committee of professional music educators who follow a procedure to evaluate each composition for artistic value and quality and then each music selection is further categorized based on instrumentation/voicing and difficulty. Music literature selected is added to the requisite required Music List. These lists span nearly the entire length of music history through today. Each list is revised annually with new music selections added as well as extant selections removed from the list. Music selections included on the Required Music Lists for each component are not included as a part of, nor to promote any ideology, faith tradition, or social movement either past or present.

Discussions of the demographic background of each and every composer/arranger is encouraged. These discussions can help to inform and possibly inspire students to discover that there are and have been composers with whom they can identify.
