May 2023 Report

- The Middle School, Concert Band, Symphonic Band, and Jazz Band Requirements were posted to the FBA site on Wednesday, May 3, 2023.
 - Pay close attention to the specific editions of the books that are used for the requirements.
 - <u>The 9-10 Concert Band Bb Clarinet (and Eb Clarinet) audition will now be from the Melodious and</u> <u>Progressive Studies Book 1 by David Hite</u>
 - The chromatic scale "minimum required tempo" is replaced with a "suggested tempo", and there is now a time limit for the performance of the chromatic scale specific to each band.
 - The required scales now have set range limits for each instrument, and are different for each level band.
 - Check back often for necessary clarifications/corrections to the requirements.
- All-State coordinators have made contact with their conductors and are working to gather information for the 2024 bands.
 - MS Honor Band Conductor- Kerry Waldo
 - MS All-State Band Conductor- Paul Destito

- The following suggestions from districts were reviewed:

District 1:

Request to release previous year's All State Sight Reading material as a practicing/teaching resource for students and directors to use in preparing for All State auditions/sight reading procedures.

-Past years Sight Reading will be shared with directors. An update on how this will work will be explained at the June board meeting.

District 3:

Suggest that we change the order of the percussion all state auditions for all levels. As currently constructed, the audition requires students to move an inordinate number of times.

Having recorded these auditions in my district several times, the mental toll and uncertainty these logistical maneuvers require while also requiring the directors to maintain a script and not offer feedback is unnecessary. These movements and changes of instrument could be significantly reduced in number by simply placing the mallet etude as the last required etude. This would allow students to play their mallet etude, scales and mallet sight-reading all at the same station. The proposed order for the audition would be: Timpani Etude, Snare etude, Mallet etude, Scales, Mallet Sight-reading, Snare sight-reading.

-After review, the committee feels this is a good idea. This new order will be implemented with the Fall 2023 auditions.

District 6:

Would the All-State committee consider adding the option to upload All State Contracts to the FMEA / All-State portal for All State coordinators to receive documents digitally?

-Josh is going to look into this, an update will be provided at the June board meeting.

Double/triple check all audition information before posting.

-Multiple people proof the audition requirements. Due to the magnitude of the task, there is still room for error.

Check all scripts for accuracy and typos.

-The All-State Committee and the Jazz Committee will continue to edit and proofread scripts.

Standardize how music is distributed. Last year jazz students had to go to Apopka High School's band website and log in to print their music.

-Moving forward all music will be distributed through MPA Online for greater consistency.

Consider writing original etudes for auditions that can be posted directly to the FBA site to alleviate any clarifications or corrections throughout the summer. This would ensure all students receive the exact same music for auditions.

-Our current etudes are written with pedagogical elements that are specific to every instrument. We worry that exercises composed on a yearly basis could lack the necessary pedagogical elements for each instrument.

Add Toms & Conga to the list of instruments to be provided at All-State instead of brought by students.

-These instruments are not considered to be "large equipment" and will not be provided by FMEA.

District 9:

What is the rational that flutes are the only section that has to play the Chromatic scale 3 octaves starting in 7th-12th grade for All-State auditions?

-Flutes are not the only section, clarinets also have a 3 octave chromatic requirement at the middle school level. For pedagogical reasons these two instrument families have a three octave requirement before others. This assures that these students have a consistent tone quality and technique control throughout the full range of the instrument because these two instrument families have more vast range demands in band music at the all-state level sooner than most all other instruments in the band. By evaluating a flute/clarinet performance of the chromatic scale in 3 octaves, judges can assess the player's ability to produce a clear and resonant sound across different registers. It allows judges to compare and rank candidates based on their ability to execute a fundamental exercise that is widely recognized in music education. It challenges them to expand their technical skills, range, and musicianship, encouraging continuous growth and development as they progress to play demanding band parts.

District 15:

All State and Technology Committee to add sound leveling options within the MPA Online program

- Josh discusses this in the Technology Committee Report. Essentially since this is a web based system not as much can be done to adjust levels through the website. However computer settings and microphone settings will make a big difference. Training will be provided before auditions in September on how to adjust settings for the best recording quality.

District 16:

All State Group perform in concert hall

-We are performing in the best spaces we have available to us. The Straz is only available for use when there is not a large production booked at the same time as FMEA.

District 19:

Information regarding the All-State Honor Bands should be available before registering students. This will help families plan and be informed of their expectations before committing.

Sight-reading and/or MPA Committee: Sellers

A discussion and action need to take place concerning electronic devices in the sight-reading room at concert music performance assessments. During the three sight-reading MPAs I judged this past season, there were seven different occasions when I had to stop the sightreading process, by pausing time during the preview period to handle various cell phone issues (parent not following my request to power down, device ringing during a preview period, etc.). Discussions in committee should include: The use of ABUNDANT signage outside and inside the sightreading room regarding electronic devices, stringent disqualification policy regarding the use of electronic devices during the sight-reading process, with this policy stated during the sight-reading judges' script. This policy should clearly state that an infraction will cause the band to be disqualified from both the concert and sight-reading categories of the CMPA, with adjudicators' comment sheets destroyed.

Response: The committee suggests the design and implementation of signage (similar to our state's standardized tests) to be posted in and around the sightreading room. The security of our testing materials must be handled in a professional yet serious manner. While most observers do not have ill intent while recording their child in the sightreading room, it is critical that we maintain a secure testing environment.

The difficulty of literature defines the developmental appropriateness of what is being assessed. There should not be a cap on sightreading for middle school just because they are middle school.

If a director is feels grade 4 or 5 music is developmentally appropriate for middle school, they should be held to the same sightreading standards of high school bands programming music of the same difficulty. Additionally, I suggest that and average of the two graded selections opens up the door for some potential challenges when it comes to programming. Perhaps the highest grade difficulty should dictate the sightreading category. Permutations of classification based on difficulty of most challenging graded stage performance could look something like:

Technology Committee Report Florida Bandmasters Association May 2023

General Technology Information

- FSMA is now accepting credit card payments for school renewal invoices. Payment instructions are at the bottom of each invoice. Counties that pay as a group must continue to pay by check at this time.
- We are aware that many school districts are now blocking Google services district-wide. It would be cost-prohibitive to move our FBA Google Workspaces accounts to Microsoft 365 because we are not eligible for any non-profit discount from MIcrosoft like we are with Google. Board members who need access at school are encouraged to work with your school's I.T. department and administrators to find a solution to allow access to the FBA Google Workspaces on your FBA district-owned laptop if you do most of your FBA work at school.
- FMEA/FSMA/FBA/MPA Online websites have recently migrated to a new web server. Everything should run faster, but there may still be some minor bugs to work out, so if you notice any problems, please email Josh@fmea.org.
- New District Chairs:
 - Please work with your previous district chair to transfer access to your district's FBA Google Account. Be sure to update both the password and phone number in the account if you are using 2-factor authentication. Email Josh if you need to reset the password.
 - Please plan to watch the *MPA Online District Chair Training Videos* before the June board meeting. MPA Online switches over to the new school year on June 20.
- Look for an email from Josh (sent to your FBA email address) with the new year's District Chair Access Password around June 20.

From December 2022 board meeting:

D-15: Meeting 2 All State and Technology Committee: Richard Uhler suggested to add sound leveling options within the MPA Online program.

D-22: Meeting 2 Suggestion to FBA Committee to have Josh add microphone adjustment settings to the MPA Online interface.

Because the new all-state recorder is web-based, and web pages have very limited ability to control hardware on the machine due to security concerns, the only options for adjusting recording levels are in the Windows or Mac "Settings" apps in conjunction with the physical input control on the USB microphone or hardware interface. This is addressed in the training video posted on the FBA website, and it is recommended that each district do mock auditions early to give all recording operators the opportunity to practice the process of setting levels and testing everything on the actual equipment that will actually be used. Many bugs were worked out between the start and end of the all-state audition window last year, and there were virtually no problems by the time FVA started their recording in early October, but there is still the possibility that some "skipping" might occur in the recordings on certain computers so testing **every computer** is important.

JHMS Representative: Suggestion to Technology/Dr. Bula - Make the accepted payments more prevalent on all invoices with "NO PERSONAL CHECKS" more noticeable (larger font, bold, etc.) (referring to the invoice for the Middle School Honor Band)

This has been added to the invoices for all honor bands.

From the May 2022 board meeting:

Dist. 19 - Meeting 3 Technology: Make MPAonline an app

App development is very different than the web development process used to write MPA Online. To re-write all of its functionality into an app would take a team of developers years. There was an effort several years ago to make the website more "mobile-friendly," and many functions are now easier to use on a mobile web browser. This has not been a high priority because many of the data-entry tasks that directors and district chairs do are easier to accomplish with a real computer and a real keyboard rather than a tiny keyboard on a tiny screen, regardless of whether it's a mobile-friendly website or an app.

If there are specific features of MPA Online that you feel need to be more mobile friendly because it would be more beneficial to be able to do on a phone instead of a laptop, please email those suggestions to josh@fmea.org.

From the December 2021 board meeting:

Dist.4-meeting 2 Technology Committee: Would it be possible to set up an adjudicators' portal in MPA Online for adjudicators to record comments on their own device (phone/tablet) and upload them directly to MPA online like other organizations do? We have had issues with our MP3 recorders not working correctly, or an adjudicator struggling to use the MP3 recorders. Usually the first band at an event has at least one recording that is incomplete or missing due to issues with the MP3 recorders or user error. Allowing adjudicators to use a device they are more familiar with would help this issue. If adjudicators had the ability to upload their comments directly to MPA Online this would allow comments to be available immediately, or unlock when at a time the district chair has set. This would also save the district chair the work of uploading comments to MPA Online the day after an MPA if there is no wi-fi available at the MPA site.

We do need to keep the momentum going in our evolution away from typewriters, paper, pencil, and cassette tapes. We are making progress, and some kind of a mobile app or web portal for judges to record audio commentary and enter ratings and judge-sheet data seems like the obvious next steps to make.

Concerns include the added time and expense of development, testing, hosting, and regular maintenance of such an app, variations in the age and quality of the mobile phones or computers that the judges own, variations in internet access at the MPA venues, and training the adjudicators to use it. As with most major additions to the functionality of MPA Online, there will need to be budget discussions with FSMA, FMEA, and the other components. I would like to hopefully have something in place and ready for testing in time for the 2024-2025 MPAs, but there can be no guarantees at this point.

As a committee, we embraced the quote "Build A Great Team (Or A Great Committee!). No One Is An Expert In Everything. The Strongest Businesses Are Built On The Smartest People - Not On One Person." This guiding phrase was the genesis for an incredible year of collaboration and growth for all of our members as we worked together to serve the Florida Bandmasters Association.

 - Currently working on updated audition scripts and a rubric review and revision for Fall 2023 auditions. Will post each as soon as they are completed.

- All State Event Review & Revision (Rehearsals & Concerts)
 - All State HS Jazz room discussion room must be large enough for the sound production of an advanced level group

 - Concert: must work with Mark Customs and the live sound crew to better define the audience experience.
 - Will reach out in advance during Fall 2023 to start the conversation.
- Jazz In Every School Survey (Submitted October 2022)
 - 200+ respondents offering a treasure trove of information to help us better serve our state
 - The primary findings were as follows
 - Improvisation: assistance with creating a basic foundation and path towards developing the language for both students and teachers alike
 - Mentoring: needing help with knowing what they should be listening for in their own ensemble and how they can work to raise the performance level within the jazz setting
 - Much more feedback was offered, however, this was prevalent throughout
- MPA Adjudication Sheet Revision
 - Sub-committee lead by Rick Fowler
 - Reviewed the purpose and viability of the current sheet to determine topics that were not present, yet germane to the jazz idiom
 - Created a new version in November 2022
 - Several committee members also serving as adjudicators used this sheet in a "double-sheet" format in 10+ districts for feedback from the band directors and other panel members.
 - Reviewed data in April and submitted to MPA committee for approval.
 - Submitted to board in May 2023 for final approval.
- Jazz Video Help Series
 - Coming Summer 2023. We have been working on topics and soliciting help from the many jazz educators we have across the state to assist in creating short, efficient videos to help our educators, and their students, within the desired topics.
 - Our goal is to continue adding to this series to create resources of jazz based topics that can be utilized immediately within the classroom.
 - We will create a portal that can both solicit ideas for topics as well as short videos from educators across the state to be reviewed for potential inclusion within the series. A "teachers helping teachers" scenario.
- Extra Ears
 - Came to life as a result of our survey findings. Jazz committee members offered to listen to recordings and provide feedback in a timely manner.

- This quickly grew into the early Spring project that served over sixty ensembles to offer assistance to not only jazz ensembles, but also to concert ensembles in preparation for their upcoming MPA performances.
- Great feedback from many of those that used this resource leading to ideas and ways to better streamline this in 23-24.
- New High School All State Jazz Ensemble Creation
 - Working with various committees and leaders within the organization to expand the All State Jazz performance opportunities at the High School level (Addition of Honor Band)
 - Proposal submitted for approval.
- Summer Jazz Institute
 - Lead by Edgar Rubio
 - Vision for Summer 2023 event.
 - Selecting clinicians
 - Event layout planning
- Middle School Jazz Ensemble Course Code Creation
 - Contacted CPalms on process of creating these codes.
 - Currently working with Orange County Public Schools to make this a reality as it has to come in the form of a district request to the state.
 - Will update in 23-24 as new information arises.
 - Goal is to have it added for 24-25 scholastic year.
- Spring 2023 Jazz MPA Adjudicator Survey
 - Received feedback from 18 Spring 2023 adjudicators
 - Results are being used to help create our goals and direction for support in the 2023-2024 scholastic year.
- Jazz Performance Opportunities
 - Will post a list in summer 2023 for planning purposes regarding Jazz Festivals and unique settings that are tremendous performance opportunities for our members and their ensembles.

2022-2023 Conclusion

This has been a fantastic year in how our committee is continuing to support our state through a wide variety of methods. Our commitment in the coming year is to use our collective expertise and findings to continue creating more Jazz learning and performance opportunities throughout our state.

Proposal:

- Rehearsal space is growing at TCC and will afford the opportunity to add this ensemble into the All State rehearsal set up
- Increasing opportunities for slots within the High School Jazz Band is paramount. One ensemble allows for two alto saxes, two tenor saxes, one baritone sax while opening up a second "Honors Big Band" band includes more opportunities for deserving students that may not otherwise have the chance to perform at such an elite level as well as bringing back newly learned skills and experiences into their own ensembles
- The state of Florida has consistently been blessed with an abundance of elite talent in the area of jazz. Our depth of performers comes not only from our Schools of the Arts, but consistently from many of our mainstream public high schools as well. Our consistent talent level will produce an ensemble that is of Florida All State quality and depth providing the high-level student experience that is expected for our event.
- As a committee, we feel that those who are nominated should be *highly encouraged* to complete a successful audition to showcase their skills and abilities. Priority will be given to those schools that nominate students that do not have a player selected for the High School Jazz Band.

- The proposed new sheet includes a scoring rubric that has not existed in the previous versions of this
 adjudication tool.
- The proposed sheet allows for more specificity regarding the Rhythm Section, encouraging both detailed adjudicator commentary as well as accountability by the director for this necessary area of performance.
- The proposed sheet elements such as "grove" and "soulfulness/spirit", which are very much part of the jazz idiom, and, recognized in similar settings by Nationally renowned organizations that create a similar evaluation-type performance experience.

Dist. 3-Meeting 3

Suggestion to Music Selection Committee - for director submissions only, to provide a brief rationale for all three possible answers. This way we can know if it was submitted for an incorrect grade level, doesn't meet a specific requirement, etc.

Suggestion to Adjudication Committee - Is it possible to be informed what happens if our nomination/trainings lapse while still waiting to receive confirmation of internships? What are our next steps if we do not get a final approval for internship? Incorporate a spot in the MPA online platform for adjudication status.

Dist. 3-Meeting 4

Suggestion for the All-State Committee - Jazz Auditions: Review the lead trumpet script to alleviate confusion amongst proctors and performers.

To the FBA Adjudication Committee,

Thank you for your hard work to keep this detailed and rigorous process alive during some very uncertain times. In light of the difficulty of this task, there are members of our district (and I would imagine other districts) that have correctly completed the adjudication process but were never offered an internship to finalize eligibility. This has resulted in their nomination and training expiring per the handbook. My suggestion to the committee is that any director who is in this situation (i.e. has been nominated by district, has attended an approved training, has turned in their application, AND has turned in their letters of recommendation), but is set to see the nomination and/or training expire should be offered an internship during the 2023- 2024 school year and be allowed to complete just that step without having to re-complete the others. Thank you for your time and consideration.

Dist. 4-Meeting 4

1. From Bill Pirzer/Lori Pirzer

Suggestion to the Auxiliaries Committee: I suggest that the Auxiliaries Committee specify in the handbook which forms of media will be accepted for students to submit their solo or aux ensemble music recordings. The forms of media vary greatly from district to district and from district to state. **Is it possible to require band directors to upload the performance songs for auxiliary events to MPA Online before the MPA begins? This would then allow a district to use MPA online to play the music for every auxiliary event at the District or State MPA without the confusion of cells phones, dongles, airplane mode, flash drives, cds, etc.

Note: Could be a Copyright issue

Suggestion to the Solo and Ensemble Committee: Can the Solo and Ensemble Committee work on creating a "Suggested Cuts and Omissions" list for grade V, VI, and VII solos and ensembles? **Reasoning**: After many years of watching my students at district and state solo and ensemble, I have witnessed many judges handle the situation of omitting sections or shortening sections in many different ways, some of which have resulted in lowered ratings or unnecessary criticism

of a students' modifications to a piece. In the handbook it states...

h. Maximum length of solos and ensembles should not exceed six minutes (see Exception). Alterations in the music performed to comply with the time limit should involve eliminating repeated sections

rather than omissions of essential sections. Exception: Students performing a grade V, VI, or VII solo or ensemble at District S&E be assigned a twelve minute time slot to align with State requirements. Solos and Ensembles should be played in their entirety, not to exceed eight minutes. Appropriate cuts, if needed, should be made such as repeats, accompaniment interludes, etc.

Much of the grade V, VI, and VII literature does not have repeated sections nor accompaniment interludes which leaves the decision to the student, private teacher or band director. Some judges are very accepting of the cuts made or if a student goes longer than 8 minutes. Other judges lower ratings if a performance goes over time. I've had several judges make a bigger deal out of the parts cut out than what the student actually played. I know this is a huge undertaking and maybe the pieces in question could be farmed out to university instructors to assist in making the suggested cuts. I feel strongly that we need to remove as much of the guess work out of the grade V, VI and VII literature.

Note: Possible Handbook change. Might require double performance slots. Would this affect the number of allowed entries by a student?

Suggestion to the Concert MPA Committee: Can the State Concert MPA Committee look into moving State Concert MPA at least one week earlier in April so it does not take place on the last full week of April? AICE/Cambridge and IB testing is now starting during the final full week of April which is majorly disrupting the student attendance to normal classes and after school rehearsals at schools that offer those academic programs. It is also limiting which day many bands are able to attend State if at all. *Note: this would put State Band MPA to close by dates to several District Concert MPA's therefore cutting down prep time.*

Dist. 6-Meeting 3

All State - Perc Coordinator... Add Toms & Conga to list of instruments to be provided. - Kolodinsky *Note: All State Committee has stated these are not able to be provided.*

All State - Jazz... More Appropriate space for the ensembles to rehearse – Kuperman *Note: This has been addressed for 2024.*

All State - Jazz... Music placed in the same place on the website - D Martin *Note: This has been addressed for 2024*

Dist. 6-Meeting 4

Brian Kuperman - Suggestion to Sight Reading Committee:

Have more sight-reading pieces that correlate to each combination of literature grade of the on stage pieces. Rationale - All 2nd bands sight read C, CC, D sight reading, but the recommended literature grade level varies from two grade 3 pieces to two grade 1 pieces, with all other combinations in between. It is not logical that bands with a recommendation of grade 3 and grade 1 music sight read the same level of music.

Solution- Create sight reading for each grade level combination in the handbook There would be 8 sight reading levels according to our current handbook combinations.

Suggestion to Adjudication Committee:

No longer allow final ratings between judges more than 1 rating apart in the same category. (category meaning music for marching MPA, with 2 music judges or concert MPA with 3 music judges.) Create new permutations in

the handbook Section III- C. 8.

Rationale - If judges are following the rubric ratings should reflect the standards FBA has set. If judges are giving ratings of superior, another judge should not give the rating of good or lower (and vice versa.). This questions the validity of the event and says more about the accountability of our rating system and judges, rather than the performance on stage.

Note: District Chairs should be covering this topic during pre-MPA Adjudicator meetings.

Monica Leimer - Adjudication Committee - Hire different judges for State S&E than District S&E.

Note: The Adjudication Committee is not responsible for hiring State S&E Adjudicators. Districts should avoid using "known" State S&E Adjudicators when possible. This sometimes limits the use of available State S&E adjudicators.

Dist. 7-Meeting 4

1. **Sight-reading and MPA Committee** - Please consider raising the prep time for the march in sight-reading from 3 minutes to 4 minutes.

Rationale: we understand the marches being used for SR are not able to be

shortened. These marches are very long and it is not possible to get through them

in the 3 minutes allotted. The 3 minutes has been in place for years, but the marches were much shorter. Instead of changing the music, change the time to allow for more success for both the students and director.

2. **Executive Committee** - Consider adding a High School representative to the board. This position will mirror the Middle School/Jr. HS rep and have the same responsibilities.

This position will also give another voice on the Exec board when setting the budget and other responsibilities bay that group.

3. Executive Committee - State S&E/Jazz Site - can more research be done to have a site in or near central or west Florida?

Note: This has been addressed for 2024. Keep in mind that finding suitable geographic sites for State S&E depends highly on how Spring Breaks are set within school Districts and the willingness to host.

4. **Executive Committee** - 5-year State Jazz Award - can the criteria be looked at for this? Currently the wording states 5 consecutive years. The problem with this is with not enough locations or locations within an ample driving distance, bands may not be able to attend even though they are eligible. Maybe this can be earned on the 5 consecutive years a bands attends State Jazz, not 5 consecutive calendar years.

A better option would be to delete this award since it is not equitable for the majority of the programs in the state. (Concert MPA 5-year award works because there are more options to attend state Concert MPA).

Dist. 8-Meeting 3

There is not a State S&E location near central Florida. Request for further research to be able to have a site central for this area

Note: This has been addressed for 2024. Keep in mind that finding suitable geographic sites for State S&E depends highly on how Spring Breaks are set within school Districts and the willingness to host.

Dist. 8-Meeting 4

-Per FBA Bylaws, must be in compliance with all FSMA policies.

-To MPA Committee: State adjudicators need to be Board Approved FBA adjudicators, same as the requirement for district. Membership does not understand how State adjudicators are not held to the same standard of training that judges for district level are held.

Note: If the membership wants this to be the criteria for selecting State S&E judges, this will drastically reduce the options available to the Exec. Director when selecting qualified State adjudicators.

-To MPA Committee: State adjudicators need to fulfill full contract for events, except in case of extreme emergency.

Note: The instance at the South/Central Jazz this year was an unavoidable schedule issue.

Dist. 10-Meeting 4

MPA COMMITTEE: Adam Tharp - reevaluate JS schools and how the sight-reading level/process (both bands SR the same level)

- o Michael Sperr revaluate 2 year MS sight-reading
- Did this MPA MS sight-reading year fit the rubric?
- Jim time on stage should be close to time on sight-reading (i.e. march)
- o Josh is there a way they can test-drive the sight-reading music? (i.e. play it at 7-honor band)
- o CJ can the committee modify the marches? Ian says yes, but we can suggest that they do it more often.

Dist. 11-Meeting 4

1. **Suggestion to the Technology Committee**: All FBA MPA forms should be able to be uploaded to MPA Online instead of having to print and email/mail. (David Wing)

Dist. 12-Meeting 4

Suggestion to the Sight-Reading Committee:

K. Johnson: Include a book for String Bass in the Sight-Reading materials. If the Euphonium BC and Tuba parts are the same, the String Bass could read the Euphonium book, but when the parts are different the String Bass student should not have to transpose the Tuba book up an octave in the Sight-Reading room.

Dist. 13-Meeting 4

Suggestion to Concert Music Committee:

As the members submit requests to have music added to the concert list; hyperlinks from JW Pepper or other web sources should be allowed in lieu of having to send a PDF of the score and MP3. The rationale is a director may not want to purchase the piece before knowing if it will be added to the list- Chris Bowen

Suggestion to Adjudication Committee:

As there are many out of state adjudicators who are active adjudicators, the Adjudication Committee should provide a way for out of state adjudicators to re-certify (Renew) remotely, via Zoom or other sources- Page Howell

Dist. 16-Meeting 3

Jazz Committee or S&E Committee:

Due to many programs not having multiple rhythm section members who can play with jazz combos of different wind players: We want to propose that jazz band rhythm section members (guitar, bass, jazz piano, and drumset) be allowed to perform in more than one jazz combo for solo and ensemble on the same instrument with different wind members.

Possible wording or suggestions could be:

-50 percent of the combo must be different performers, including wind and rhythm section players.

or

-the rhythm section member must be enrolled in two different levels of jazz combo i.e. JC3000 and JC4000.

This proposal would only affect the scheduling of rhythm section members, not wind players. (*Monica Serrano*)

All State Committee: All State Group perform in concert hall (*Tom Bowden*) Note: This is done through FMEA when the Straz Performing Arts Center is available.

All State Committee: Consider hiring sound engineers/overhead program for All State Jazz Band (*Patrick Araujo*) *Note: Mark Customs is the recording company hired by FMEA for all recordings.*

Dist. 16-Meeting4

Adjudication Committee: please offer marching renewal training at **both** FBA Summer Conference and FMEA • Proposed by Erich Rivero

Dist. 19-Meeting 3

- - Split How to Fix It to two sections and focus on Sight Reading Middle and High School
- - Add a How to Fix It Jazz
- - Add Jack Hart (retired East Ridge High School) as a Legacy member.

Note: District Chairs are to submit suggestions to the Legacy Project Chair.

Dist. 19-Meeting 4

- - Michael Jennings Start including/create Color Guard instructors in the awards. Five-year superior, Tom Bishop, etc... These awards recognize band directors, but color guard instructors have no recognition. Name the award after Joanne Dodge.
- - Ariel Reddick Technology committee show adjudicator names on MPA online once they have been hired.
- - Cory Lowery Make the FBA Handbook a searchable document to help directors find answers faster.
- - Emily Goode have an info sheet about **All-State bands** that outlines schedule, locations, etc... that we can distribute to parents so they know the expectations before auditioning. Samples are attached.
- - Aaron Janosa Music Committee review the list based on what is out of print and how many times the pieces have been performed in an effort to clean up the list.
- - John White Concert MPA Judges standardize the amount of time between songs on stage. Do we wait a certain amount of time or do we wait for the center judge to give a signal.
- - Ariel Reddick Is it possible for middle school teachers to become a judge for the Marching MPA. Clarify the three out of five marching superior rule for them? Middle school teachers tend to help high school programs and have more time available to judge. We could also make an alternative pathway for middle school directors to have this opportunity. Letters of recommendation, use the scores of the band they work with.

Dist. 23-Meeting 3

To All State Committee - Consider making the Piccolo, English Horn, Eb Clarinet, Contrabassoon, Soprano Sax auditions like the Lead Trumpet (Jazz) audition. Make it all one audition with the option of playing the color instrument audition.

Note: this is being addressed.

Dist. 23-Meeting 4

Could we look at different avenues to get solo and ensemble judges after teaching only for 3 years? Similar for Jazz and Concert with certain qualifications? (Out of state and major accomplishments?) We do have a judge shortage and district chairs have had some challenges hiring judges this year. For example, Jason Anderson wins Essentially Ellington but isn't eligible to be certified to adjudicate.

Proposals as Motions to the Board

Dist. 4-Meeting 4

Motion: To clearly specify in the handbook what a student or auxiliary event should or should not do if technical difficulties occur with the sound system during their performance. Should they stop? Should they continue? **Rationale:** I had a student have her music cutoff at State Aux MPA about halfway

through her performance. She had been trained to keep going by our instructors if anything went wrong. She got a little nervous and sped up her routine and finished 5 seconds under time (she was above time with the same routine and music at districts). I was not aware that she had been given a one rating penalty until about an hour after the performance and the

the judges had already left. The executive director contacted the lead judge and that judge said "the student should have known to stop." Why did the judges not have her stop? The student did as they had been taught and received a penalty due to an unfair circumstance. To eliminate any confusion or mis-interpretation, this should be clearly stated in the handbook.

Dist. 5-Meeting 4

B. Schmidt moves that FBA unlink Jazz MPA from Solo & Ensemble from both the district and state level. (J. Mulder seconds) - Approved

Move to strike the word "District" form the motion. State only. - Approved

***MOTION #9: DEFEATED by BOARD vote**

(Note: Most districts currently hold Jazz on other days than S&E days. This would create a site and schedule issue for State.)

Dist. 6-Meeting 3

Leimer - Motion: Limit the number of FBA committees that a member can serve on to 3 (including committees tied to specific offices in the association).

Rationale: This would allow more members to get involved with committees. There are members that are serving on upwards of 6-7 committees at the same time. This would also give opportunities for different perspectives to be shared in our association's committees.

2nd Lopez Vote: Pass

***MOTION #10: DEFEATED by BOARD vote**

(Note: this would be a By-Laws change and would deny the incoming FBA President the right to select those members they wish to serve as Committee Chairs.)

2. Leimer - Motion: Establish a "High School Representative" position on the FBA Executive Committee to mirror the "Middle School Representative."

Rationale: The position Middle School Rep was established at a time when the positions of President, Past-President, and President-Elect were traditionally being held by high school band directors. This was to give a voice at the front table to middle school directors in the association. Now, we have middle school band directors holding the offices listed above regularly so it seems that it only makes sense to add a High School Rep position to ensure that the voice of the high school band directors is equally represented at the front table. Currently, 2 of the 3 President positions are held by middle school band directors. With the addition of the Middle School Rep, this puts 3 middle school directors and only 1 high school director on the Executive Committee, thus leaving the high schools underrepresented. There could even potentially be a situation in the future where all 3 President positions are occupied by middle school band directors. Having a standing position at the front table to represent the interests of the high school band directors makes sense.

- - Sightreading:
- - To direct the Sight Reading Committee to keep and review (yearly) appropriate guidelines, describing maximum limitations (rubric) for the literature our students are expected to sight read in our Music Performance Assessments. See attached Content Limits as a starting place (these used to be on the website).
- - Rationale: If we value the sight reading process, we should carefully select music both of quality and of **specific skills** for our students to be evaluated. Currently, the committee uses the publisher's grade levels to determine the level of sight reading for each group (https://fba.flmusiced.org/media/1791/fba-sight-reading-rubric-2018.pdf). If we are to be taken seriously as an organization and use Music Performance Assessments as a valid assessment for our students, we need to define the musical skills that our students are to perform (sight read). The result of using a publisher's publications guidelines is that some middle school bands are reading **harder** music than they performed on the stage and some high schools are reading music well below their level.
- - Published performance time should be no longer than 2 minutes with total measure parameters between 52 and 64
- - As a side note I have no issue with the current publisher of our sight reading materials. I am very thankful that we are able to get books prepared for our students to use, and my students enjoy performing the works published. They are always exciting and fun, providing the opportunity to teach students to play rhythmically accurately. However, as fun and exciting as these works may be, they are not always the best choices in the sight reading room.

Rationale: As band directors, our job in every circumstance is to improve the instrumental performance of our students. After every performance, we should provide for our students as individuals or ensembles both in what they do well and ways to improve. This can be in a formal, written way like solo and ensemble adjudication sheets, or informal in class debriefings or conversation. As professional musicians, the ability to reflect on a performance, decide what went well and what needs to be improved is one of our greatest tools to continue performing, learning, and earning our next performance opportunity.

Every performance in FBA follows this essential practice, except All-State auditions. Students spend months practicing for this high - stakes audition and after enduring the practice and the stress of the audition - they are provided with no feedback from this audition. All they receive is a "Yes" and if they don't make it, they know nothing about the audition. I understand the time the committee spends to listen to all the recordings and that creating a paper like the solo and ensemble judges' sheet would be a poor use of time and resources. Also, as directors we're actively recording other students and aren't provided any results for the students that helps us better prepare All State students in the future.

This would measure growth in a way that our current system of "Yes / No" doesn't. A student that scores high on the rubric but doesn't make the ensemble knows they are a great player, there's just too many good players to put in one ensemble. Or a student that auditions two years in a row and doesn't make it can see the difference in their score from one year to the other - especially if this student improves his number. Instead of feeling like a failure, that student can see that although he/she didn't make it, the audition was still much better. The students that show up to All State Auditions are high - performing students who feel like not making the All State band is a failure. We need to do better for these students and show them the growth they achieve, even if they don't make the ensemble. The current system is essentially pass / fail and the hundreds of students that miss the cut off shouldn't feel like a failure. FBA's current system is failing them.

Section 4. CHAIRPERSONS Chair-persons of standing committees shall be appointed by the President for a twoyear term commensurate with his/her term of office. The President shall appoint chairpersons to fill expired terms.

Proposed change: TERM OF SERVICE A. TERM OF SERVICE A. Except where limited by State Officer's term of office, membership on all standing committees shall be for a term of three (3) years. Upon completion of a three (3) year term, members must wait at least one year before being appointed to serve on the same committee. Oversight and review of members' years of service and committees will be done by the President.

Rationale: Many members have expressed concerns that some committee members have served for over ten years. Long terms for committee members do not allow other interested members the opportunity to serve the organization and ensure a varied representation demographically.

In May of 1989, Jack Crew took a momentous step to develop what some call the "starred list" and what others refer to as "significant literature" on the concert music list. Crew contacted 13 university band directors to review the list, propose additions, deletions, but more importantly to indicate what they believed to be the most influential, musically rich, and educationally valuable compositions for students to study. In his eyes, when the FBA discontinued using required pieces for festival in 1971, we gained freedom and flexibility, but we also lost a valuable resource to guide young band directors as to what is some of the best quality band literature. His original purpose of the significant literature list would be to require every band to play one at MPA, but the membership of the FBA executive committee voted this down in 1990. Crew also motioned that any band performing two pieces of significant literature at MPA and earning straight superiors at district and state be awarded a "Superior with Distinction" which was passed by the executive board, but may have died sometime after.

Crew's work with 13 university band directors resulted in 239 pieces on the list of 1,146 pieces being given the label "significant literature." In 1994, 26 pieces lost this status, and 36 gained this status. Four more gained this status in 2002. As you can see, this list has largely become stagnant, representing values of the more than thirty years past as it has not been maintained, partly due to what anyone can see as the massive amount of effort that would go into updating it.

Because of this, I move that the FBA update the significant literature list. This would be a modern replication of Jack Crew's work. I suggest the FBA designate an individual to coordinate this effort, most likely through or in cooperation with the concert music committee. This individual would work with the FBA membership to identify a diverse body of outstanding collegiate or professional band directors from whom we might solicit their feedback as to what pieces on our list should be marked as significant literature, or if any should have this designation removed. Crew's efforts in 1989 validated the work of our hard-working concert music committee members, and for a short time made their work easier. His work served our profession well, and it is time to maintain it Motion proposed by Tim Groulx, second by Jonathan Maerkl

Please accept the following proposal to the Executive Board

To direct the Sight-Reading Committee to keep and review (yearly) appropriate guidelines, describing maximum limitations (rubric) for the literature our students are expected to sight read in our Music Performance Assessments. The attached Content Limits are a starting place (these used to be on the website).

Rationale: If we value the sight-reading process, we should carefully select music both of quality and of **specific skills** for our students to be evaluated. Currently, the committee uses the publisher's grade levels to determine the level of sight reading for each group (https://fba.flmusiced.org/media/1791/fba sight-reading-rubric-2018.pdf). If we are to be taken seriously as an organization and use Music Performance Assessments as a valid assessment for our students, we need to define the musical skills that our students are to perform (sight read). The result of using a publisher's publications guidelines is that some middle school bands are reading harder music than they performed on the stage and some high schools are reading music well below their level.

This year, the MD sight reading was much improved, due to the changes the board made last year. However, the MC Overture was INAPPROPRIATE for that level. The content included chromatic melodic material, ties over bar lines, and first and second endings in each section of the march. In the overture, there were constant rests on beat 1 (syncopation), and eighth notes followed by rests. These are all things that belong in MB, not MC. For sight reading in MC - the march should follow the same requirements as MD. These bands are playing .5 to grade 1 marches on stage.

As a side note - I have no issue with the current publisher of our sight-reading materials. I am very thankful that we are able to get books prepared for our students to use, and my students enjoy performing the works published. They are always exciting and fun, providing the opportunity to teach students to play rhythmically accurately. However, as fun and exciting as these works may be, they are not always the best choices in the sight-reading room.

Please accept the following proposal to the Executive Board By-Laws Change

Article 4, Section 8.L. Sight Reading Music Committee Organization: Chairperson, a representative from each of the following: <u>junior high/small</u> middle school, <u>large middle</u> <u>school</u>, small high school, large high school, <u>college/university</u>

Duties:

- 1. <u>The maintenance of Content Limits used to select music for bands to sight</u> read at Music Performance Assessments to be published on the website
- The selection of sight-reading music for use by bands in all classifications at the District and State_Music Performance Assessments <u>following these limits</u>. <u>The</u> <u>technical requirements of the music should never exceed the Content Limits for</u> <u>any given class</u>.
- 3. The establishment and maintenance of a list of sight-reading selections used at past Music Performance Assessments to be published on the website.

Motion to Amend Florida Bandmasters Association Bylaws Article IV, Section 4 - Chairpersons (amendment in bold italics below)

Whereas the Florida Bandmasters Association is dedicated to promoting and supporting excellence in instrumental music education; and

Whereas, the appointment of committee chairs in an important responsibility of the FBA President, who should have the authority to appoint individuals who are best suited to lead these committees; and

Whereas, regular turnover in committee chairs can help ensure that fresh perspectives and ideas are brought to bear on the important work of these committees;

Therefore, be it resolved that the Florida Bandmasters Association Bylaw Article IV, Section 4 be amended as follows:

- A. Chairpersons of standing committees shall be appointed by the President for a two- year term commensurate with his/her term of office. The President shall appoint chairpersons to fill expired terms
- B. Chairpersons shall not serve more than one consecutive term as chair of the same committee, but may continue to serve on the committee in a non-chair capacity.

This amendment shall take effect immediately upon adoption.

I move that this motion be adopted by the executive board of the Florida Bandmasters Association.

Proposal #2 to the Executive Board and/or Sight-Reading Committee - R. Powali / R. Ross

- 1. A Sight-Reading Rubric/ Content Limits should be adopted and posted when selecting pieces for Sight-Reading.
 - a. The Rubric/ Content Limits should be posted on the FBA Website for Directors to access in order to properly prepare students for Sight Reading.
 - b. The Rubric/ Content Limits should be followed to accurately assess students of that level and their sight-reading ability.
- 2. Sight Reading pieces should have a designated range of measures for each appropriate classification level.
 - a. MD/MC/MB have been considerably long to perform and prepare
 - b. Young Embouchures are not fully developed to play 100+ measures when including repeat signs in sight reading.
 i. Some Grade 1 and 2 pieces on the list are only 40-50 measures
 - c. Preparation time for the Sight-Reading performance should be considered if we are to
 - cap 3/5 minutes.
 - i. More measures is less time to prepare spots
- 3. Repeat signs should be appropriate to the classification of the band.
 - a. 1st and 2nd endings should be limited to no more than 8 measures, 4 for MD/MC/MB
 - i. Marches and music on the list follow this guideline
 - ii. Some marches contained 5 measure 1st endings, being uneven in a phrase to jump to the second ending when needed.
 - b. Young embouchures should be considered for length of music.
 - 4. Sight Reading should be written by composers based exclusively on the Sight-Reading Rubric/Content Limits for each classification
 - a. Great strides have been made to make Sight-Reading more consistent
 - c. Current System, the Sight-Reading Committee is given a set number of songs, and then

matched to the criteria as best as possible

Uneven 1st and 2nd endings

Middle school embouchures are on 1.5-2.5 years of playing, and they also play 3 pieces of music on stage. Music quality has been questionable, awkward melodies, MD contains some chord structure, but sometimes experiments with 2nds. Pieces contain parts that last for 1-3 beats and are passed on to other instruments, which leads to awkward entrances.

Many other states have composers write the sight-reading music based on the rubric and guidelines, which guarantees that it will follow the rubric and the guidelines.

Four sites were utilized for the State Solo & Ensemble, Jazz Band, and Auxiliary MPA events. The North/Central S&E Site was at Bartram Trail HS in St. Johns County, March 16-18, 2023. The South/Central S&E site was at Wellington Community High School, March 20-22, 2023. The Collier County State Auxiliary MPA was at Palmetto Ridge HS, March 23, 2023. The Northwest S&E site was at Lincoln High School, March 25, 2023.

The Listening Block schedule was developed to make sure each and every band has an audience when performing at the State Band MPA, and to give attending students the opportunity to hear groups they may not have opportunity to hear.

Most block schedules work best with five bands and with no more than six bands. There were a few four band blocks at the South, Central, and North site.

Each band is able to stay in the auditorium for the performing groups entire performance before leaving for warmup.

Suitable breaks were built into the Schedule to allow for smooth transitions from one Listening Block to the next, mainly by use of the Lunch and Dinner break

Many positive comments were shared with the Exec. Director about the Listening Block format. Some still wanting to know how to incorporate a Listening Block in some form at the District level (Sightreading throws a huge roadblock into using it at the District level).

There were a few instances in which a band was late for their Listening Block due to bus issues, which were unavoidable. Only two instances around the State of directors not staying for their entire Block, with one resulting in the final band in a Listening Block only having one band in the audience.

The Executive Director recommends a continuation of the Listening Block for the State Band MPA.
