Florida Bandmasters Association Hall of Fame Annual Report 2025-26

The 2025 Hall of Fame Weekend was held on November 15th and 16th, 2025, at Stetson University in DeLand. On Saturday night, we were all treated to a fantastic concert by the Southern Winds, under the direction of Dr. Douglas Phillips honoring the 2025 Roll of Distinction inductees, Dr. Patrick Dunnigan, the Director of Bands and Professor of Music at Florida State University, and Mr. Fred Schiff, FMEA Board Member, Chair of the Corporate and Academic Partners Committee, as well as President and owner of the All-County Music in Broward County.

On Sunday, the Hall of Fame concert was held featuring the outstanding Stetson University Symphonic Band, under the direction of Dr. Chandler Wilson, Director of Bands at Stetson University, honoring the 2025 Hall of Fame inductees: Richard Davenport, the Director of Bands at Deane Bozeman School in Bay County, and Melvin Maxwell, retired Director of Bands at Naples High School in Naples.

Prior to the concert on Sunday, a banquet was held honoring all four of these inductees on the campus of Stetson University.

A tremendous thanks must go to Dr. Chandler Wilson, the outstanding musicians in the Stetson University Symphonic Band, the entire music faculty and administration at Stetson University, and of course Dr. Doug Phillips and the wonderful musicians in the Southern Winds.

If you haven't attended a Hall of Fame Weekend, then I encourage you to make plans to attend this November. The FBA is so much more than an organization that simply assesses fees and administers MPA's. While not perfect, it's an organization that can and will help us grow as teachers and as individuals if we get involved, learn from each other, and use the resources available. We have a rich history of people who have dedicated their lives to maintaining a high standard of excellence by passing on what they know to the next generation. The Hall of Fame weekend represents this rich history. I encourage you to learn about the history of the FBA in this state. Watch Legacy videos on the FBA website. Learn about the lives of those who came before you and attend these concerts and activities.

As a reminder, any FBA member can submit nominations for consideration to the Hall of Fame and the Roll of Distinction. Each year new inductees are selected by the Hall of Fame Board of Directors, which are living members of the FBA Hall of Fame. The dates for the 2026 Hall of Fame Weekend are November 21-22, at Stetson University.

Now, on behalf of the FBA Hall of Fame Board of Directors, I would like to announce the inductees for 2026. The Roll of Distinction inductee is the retired Director of Bands at Stetson University and the Conductor of the Southern Winds, Dr. Douglas Phillips.

The first inductee is the Director of Bands at Union County High School, Kelly Dorsey.

The second inductee is the Director of Bands at Crestview High School, Jody Dunn.

C. Qualifications for the Office of President-Elect

To be considered for the office of President-Elect, a candidate must meet the following qualifications:

1. Be an Active Full Member of the Florida Bandmasters Association.
2. Have a minimum of fifteen (15) years of teaching experience, the majority in the state of Florida.
3. Have served on the Executive Board of the FBA for no fewer than two (2) years.
4. Have a record of consistently high-caliber band performance under their direction.

Section 4. ELECTION OF MIDDLE SCHOOL/JUNIOR HIGH REPRESENTATIVE

Replace Subsection B with the following:

B. Qualifications for consideration for the office of JH/MS Representative

1. ~~The candidate should have been teaching for no less than 15 years.~~
2. ~~The candidates bands should consistently be of the highest caliber.~~
3. ~~The candidates bands should have a high percentage of S&E participation.~~

To be considered for the office of Junior High/Middle School Representative, a candidate must meet the following qualifications:

1. Be an Active Full Member of the Florida Bandmasters Association.
2. Have a minimum of fifteen (15) years of teaching experience, the majority in the state of Florida.
3. Have a record of consistently high-caliber band performance under their direction.
4. Have bands with a high percentage of participation in Solo & Ensemble Music Performance Assessments.
